



Coronavirus Update and Action Plan

ACT have reported 0 new cases in the past 24 hours leaving ACT's total at 113.

The total Covid-19 cases in NSW have increased to 3303, 14 new cases today. Of the 14 –

- 4 are returned travellers in hotel quarantine
- 2 acquired the virus whilst visiting VIC
- 8 are Crossroads Hotel patrons

Coronavirus Hot Spots

The Crossroads Hotel in Casula has become a site of a concerning new cluster of COVID-19 cases - with further cases being confirmed by NSW Health today. Anyone who may have visited the Crossroads Hotel between 3 and 10 July 2020 are urged to isolate immediately and get in touch with their manager

While investigations into this cluster of COVID-19 cases is continuing, people who visited the Crossroads Hotel between 3 and 10 July 2020 are encouraged to get tested, regardless of whether they are showing symptoms. This will help us in assisting the NSW Government in their efforts to establish the source of infection at the hotel.

Form1 urge anyone who attended the following venues during these dates to watch for symptoms and to get tested for the virus.

- The gaming room at the Picton Hotel on July 4, 5, 9 and 10. Anyone who was in this room has been urged to self-isolate for 14 days.
- The Planet Fitness gym at Casula from July 6-10.
- Canterbury Leagues Club on July 4 between 11pm and 1am on July 5.
- Star City Casino between 8pm and 10.30pm on July 4.
- Cook at Kurnell between 11.30am and 12.30pm on July 5
- Highfield Caringbah between 6pm and 9pm on July 5.
- The Merimbula RSL between 6pm and 9pm on July 5.
- The Waterfront Cafe at Merimbula between 8.30am and 9.30am on July 7.
- The Murray Downs Golf Club on July 4 and 5.
- The Narellan Town Centre shopping complex, including the Kmart, Target, Best & Less, H&M stores and food court on July 6.
- The Zone Bowling at Villawood between 11am and 3pm on June 27.

It's essential that we all take the risk of transmission very seriously and take steps to protect ourselves and loved ones:

- If you have even mild symptoms, a cold or cough, get tested and stay home until you're cleared.
- Keep your distance from others at all times even if you are well.
- If you have been in Victoria, don't mix with other people until two weeks has passed.

Form1 request that you do not travel to Victoria and if you do plan on travelling, that you notify your manager prior to travel. You will not be permitted access to aged care facilities, hospitals, or other settings with vulnerable people for 14 days after you return.
